### Three Key Steps for a Successful Case Study!

There are different schools of thought to writing a case study, but once you decide on its main purpose (challenge with result or problem with solution), you should stick to it for consistency.

It doesn't matter if it's one page or four, nor if your readership is online or gets a hardcopy; there are three key steps that every case study needs. According to Steve Slaunwhite, "readers love a good story and case studies tell the story of a great product or service and a happy customer."

Over the years, I've been involved in many different projects and now realize most of them make great case studies. For this sample, I've chosen challenge with results and one that I'm sure we can all relate to

So what are the main three?

1. **Challenge** – this is known as the problem. Talk about the problem your customer hired you for to change or improve. Use quotes from your customer if possible.

PTO at Metro Tech takes on School Committee and wins. Parents at Metro Tech were tired of their teens getting into trouble so they could get a few days off from school. "I can't afford to take time off from work to supervise my child when they get suspended;" cried Mrs. Kiley "isn't there a way to keep her in school?" It was common knowledge that if you didn't want to be in school, just pick a fight in front of a teacher and you'd be sent to the Principal's office then suspended. Another vacation for two – five days.

2. **Solution** – This is where you talk about how your product and/or service provided the solution. But, to do this properly, you need to discuss what other steps were taken to solve the problem.

The PTO met on a regular basis and put a plan together to have an in-house suspension program at the school. With the approval of the parents, the PTO President attended the next six months of school committee meetings and voiced this group's concerns, and brought back the school committee's concerns. In between meetings, she called all 12 school committee members at their homes. Not to be defeated, after 5 months a retired parent stepped forward to take on this position until the school would hire someone.
